## Zoning By-law Amendment

**TAKE NOTICE** that the Council of The Corporation of the Township of Clearview has received application for an amendment to the **Zoning By-law**. The application is being considered under the requirements of the Planning Act RSO 1990 c.P.13 s. 34 and Ontario Regulation 545/06. The purpose of this notice is to provide notice of the application and public meeting and to provide more information on the details of the application.

#### **Purpose & Effect**

The purpose of the application is to request a site-specific amendment to rezone a portion of the subject lands from 'Agricultural' (AG) Zone to 'Agricultural - Residential Use Exception' (AG-ER) Zone to prohibit the use of the lands for residential purposes.

The effect of the application is to facilitate the severance of a surplus dwelling lot from the subject lands.

#### **Appeal Rights**

If you wish to be notified of the decision of the Township on the proposed amendment, you must make a written request to the Township using the contact information below.

If a person or public body would otherwise have an ability to appeal the decision of the Township to the <u>Ontario Land Tribunal</u> but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township before the proposed amendment is adopted or passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township before the proposed amendment is adopted or passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

Subsection 34(19) of the Planning Act defines the persons/public bodies that are eligible to appeal the decision of the Township to the Ontario Land Tribunal.

Where applicable, this notice must be posted by the owner of any land that contains seven or more residential units in a location that is visible to all of the residents.


