# 4. Business Arising from the Minutes

# 4.1 Climate Action Recognition Program Update

Briar Kelly, Community Economic Development Officer, provided a verbal update, noting that two nominations have been received to date in the Business and Citizen categories, and encouraged Committee members to help promote the program to increase nominations, including in the Student category.

It was noted that nominations are submitted online and must include all required information. The Committee discussed eligibility and agreed to maintain broad criteria aligned with the program's mandate for this year, with a debrief and potential refinements to be considered in 2026.

## 4.2 Emergency Preparedness

The Committee engaged in an open discussion on public safety considerations during storm events, including risks associated with downed power lines and improper generator use. It was noted that public education resources are available through Hydro One.

The Committee discussed general communication approaches related to severe weather and public safety, including the use of existing communication channels and potential outreach initiatives. Various options were noted, with no specific direction determined at this time.
