- 1) That Council, in recognizing the importance of national defence and supporting Canada's efforts to keep pace with new and emerging threats such as hypersonic weapons and advanced cruise missiles, respectfully opposes the use of valuable agricultural land in Clearview Township for the use of a Receive Site for National Defence's Arctic Over-The-Horizon (A-OTHR) project; and,
- 2) That Council direct staff to send a letter outlining the above to The Honourable David J. McGuinty, Minister of National Defence, with copies to The Honourable Heath MacDonald, Minister of Agriculture and Agri-Food; The Honourable Julie Dabrusin, Minister of Environment and Climate Change; Simcoe-Grey MP Terry Dowdall; Nottawasaga Valley Conservation Authority, Township of Essa, Township of Springwater and the Town of Wasaga Beach, Keith Currie, President of Canadian Federation of Agriculture, and Senator Rob Black, Chair of Standing Senate Committee on Agriculture & Forestry.
